THIS IS TO CERTIFY that the amended Articles of Incorporation of

P-H-O-E-N-I-X PETROLEUM PHILIPPINES, INC.

(Amending Article VI by increasing the number of Directors to seven (7) and Article VII thereof)

copy annexed, adopted on <u>January 15, 2007</u> by a majority vote of the Board of Directors and by the vote of the stockholders owning or representing at least two thirds (2/3) of the outstanding capital stock, and certified under oath by the Secretary and a majority of the Board of Directors of the Corporation was approved by the Commission of this date pursuant to the provisions of Section 16 of the Corporation Code of the Philippines, Batas Pambansa Blg. 68 approved on May 01, 1980, and copies thereof are filed with the Commission.

Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing company, pre-need plan issuer, general agent in pre-need plans and time shares/club shares/membership certificates issuers or selling agents thereof. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

AMENDED ARTICLES OF INCORPORATION

OF

P-H-O-E-N-I-X PETROLEUM PHILIPPINES, INC.

(Formerly: DAVAO OIL TERMINAL SERVICES CORPORATION)

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a stock corporation under the laws of the Republic of the Philippines:

THAT WE HEREBY CERTIFY:

FIRST:

That the name of the Corporation shall be

P-H-O-E-N-I-X PETROLEUM PHILIPPINES, INC.

(As amended on June 5, 2006)

SECOND: That the purposes for which the corporation is formed are as follows:

Primary Purpose

To engage in, conduct and carry on the business of buying, selling, distributing, marketing at wholesale and retail insofar as may be permitted by law, all kinds of goods, commodities, wares and merchandise of every kind and description and all merchandise, supplies, materials and articles, such as but not limited to petroleum, lubricants and other chemical products, as shall be necessary or expedient in conducting the business; to enter into all kinds of contracts for the export, import, purchase, acquisition for its own account as principal or in representative capacity as manufacturer's representative, merchandise broker, commission merchant, factors or agents, upon consignment of all kinds of goods, wares, merchandise or products, whether natural or artificial. (As amended on June 5, 2006)

Secondary Purpose

To engage in the business of operating oil depots, storage facilities and allied services

THIRD: That the place where the principal office of the Corporation is to be established or located is at Stella Hizon Reyes Road, Bo. Pampanga, Davao City, Philippines. (As amended on Doc. 2007)

FOURTH: That the term for which the Corporation is to exist is FIFTY (50) years from and after the date of incorporation.

The stockholders of the Corporation shall have no pre-emptive right to subscribe to any issues or dispositions of shares of any class. (As amended on January 15, 2007)

CERTIFICATE OF AMENDMENT OF THE-ARTICLES OF INCORPORATION OF

P-H-O-E-N-I-X PETROLEUM PHILIPPINES, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned Corporate Secretary and majority of the Board of Directors of P-H-O-E-N-I-X Petroleum Philippines, Inc. (hereinafter, the "Corporation") do hereby certify that at the meeting of the Board of Directors held on January 15, 2007 at the principal office of the Corporation, these amendments were unanimously approved, and at the special meeting of the Shareholders of the Corporation called for the purpose of amending the Articles of Incorporation, held on January 15, 2007 at the principal office of the Corporation, at which meeting, shareholders owning or representing at least two-thirds (2/3) of the outstanding capital stock of the Corporation were present or represented, the following resolutions were, by unanimous vote of the shareholders present/represented, adopted:

"RESOLVED, that the Corporation be, as it is hereby, authorized and empowered to amend its Articles of Incorporation to effect the following amendments: (a) increase in the number of directors, and (b) denial of pre-emptive right;

"RESOLVED, FURTHER, to amend Article Sixth of the Articles of Incorporation of Corporation to read as follows:

'SIXTH: That the number of directors of said corporation shall be seven (7).'

"RESOLVED, FURTHERMORE, to amend Article Seventh of the Articles of Incorporation of the Corporation to read as follows:

'SEVENTH: That the authorized capital stock of the corporation is Four Hundred Million Pesos (\$\frac{1}{2}\$400,000,000.00) in lawful money of the

Philippines, divided into Four Hundred Million (400,000,000) shares with a par value of One Peso (\$\mathbb{P}\$1.00) per share.

The stockholders of the Corporation shall have no pre-emptive right to subscribe to any issues or dispositions of shares of any class.'

"RESOLVED, FINALLY, that any one of the President, Corporate Secretary or any Director of the Corporation be authorized and empowered to submit or cause the submission of a copy of the Amended Articles of Incorporation of the Corporation, certified by majority of the directors and the Corporate Secretary, to the Securities and Exchange Commission, to sign, execute and deliver any and all documents, and to do any and all acts, necessary and proper, to give the foregoing resolutions force and effect."
